2016-2017 POLICIES

• **Registration** A student's registration will NOT be complete until the Registration Form is completed and signed. It must be accompanied with the Registration Fee of \$25.00 per person or \$40.00 per family, and first tuition installment. Please remember this registration is for the ENTIRE School YEAR. We do not accept students on a month to month basis.

• **Tuition** Tuition should be paid with the registration form no later than September 6, 2016. Tuition can be paid annually, semi annually, or in nine installments. If paying in installments, the first payment is due with the registration, the following payment (2nd payment) is due by the first of each month beginning in October. The Installment Plan does not reflect the amount of classes in one particular month, it is based on a year's tuition and split into nine equal payments for your convenience. SDA|MRDA does not have a billing service and is not able to mail monthly payment reminders. Semester payments will be charged at the time of registration and again on January 16, 2017.

• **Discounts** All families with two or more members enrolled in the school will receive a 5% discount off tuition (see tuition worksheet). A 6% discount will be given for paying annually (at the time of registration) and a 3% discount will be given for paying semi-annually (at the time of registration and on January 16, 2017). Discounts are applied only to classes that begin in September. Classes started or added in January are not eligible for discounts.

• **Costumes** All students will have a costume fee of \$65.00 per class. A \$25.00 non-refundable costume deposit for each class that your child is enrolled in and will be automatically charged to your credit card on file by December 1st 2016. If your child does NOT intend to participate in the year end Recital (June 2-4, 2017) you need to let us know prior to Dec. 1, 2016. **Please acknowledge this by initialing** _____.

• **Refunds** Please understand this registration is for the nine-month season September 2016 through June 4, 2017. If you must withdraw after September 7, 2016, one month's notice in writing is required in order to receive a refund of the tuition payment. A student is considered registered at SDA|MRDA until written notice is received of withdrawal. Responsible parties will continue to be charged without written notice of withdrawal. After January 15, 2017, no refunds are issued and you will be responsible for the remainder of the tuition through May 2017. ****No refunds are given for classes missed but make-up classes may be taken. Please check with your teacher for an appropriate level.**

• **Cancellations** Please check web site for snow day cancellations.

• **Supervision** SDA|MRDA is not staffed to monitor unchaperoned students before or after student's class time. If a student is under 10 years of age, parents/caregiver should remain with their student until class time begins.
