As a choreographer for the NY Knicks City Dancers 2009/2010 he is also creator/director/choreographer for various Off-Broadway dance shows. As a dance master teacher all over the world, he has also taught at national conventions including The Pulse, Dance Olympus and Dance Masters of America. In 2008 Derek released his first Street Jazz instructional DVD and was Dance Teacher's Instructional Teacher of the Month. He has been profiled in numerous articles in Dance Spirit, Dance and Dancer magazines.
